FACULTY OF GRADUATE STUDIES AND RESEARCH Ideas around policies/procedures for thesis-required programs

We discussed these a little at last Council (April), and with Fall meeting of Graduate Studies Committee

- now that FGSR is "mature" (15 years since establishment), we have experience where some areas of "policy clarity" would be helpful.
- Just as examples, talking about items like these:
 - Timing of official assignment of Supervisors, and Committee Membership; better/consistent definition of Committee, and role/duties of members; clarifying role/status of Adjunct faculty; clarity around remote participation in defences; following CAGS best-practice guidelines for student progress/status updates; clarify who gets external examiner report and when; in-camera vs. open examination of candidates in defences; etc.

Plan:

- Will convene a sub-committee of the Graduate Studies Committee (these are all GPCs) to look at a list of topics/items I provide, and review policy.
- Will be chaired by Natalia K. (PhD Bus Admin)

SAINT MARY'S UNIVERSITY SINCE 1802 One University. One World. Yours. Status of moving to a fully online graduate application

- This project has been "in the works" for almost 4 years... Now it's clear: we NEED this to remain competitive in attracting students (we are in the minority within Canada by not having a fully online app)
- Initial Project to work with company (Edge) to build our own (on the "Ezrecruit" platform) got very far, but stalled:
 - Small company, had staff turnover (and a data breach...)
 - Challenging to find staff time in FGSR over that period (before we were fully staffed as we are now)
 - Plus: needed our ITSS to develop integration-with-Banner pieces, and ITSS time limited (Banner upgrade)
- BUT: NEW START! As part of institutional project to modernize our Enterprise software ... we are acquiring Ellucian "CRM Recruit" (same company as Banner) with a "rapid deployment" ... so starting again ...

Moving forward with prof. development workshops (students, faculty)

 - launched consultation period October 2018
 - full online strategic discussion ran Dec 2018 March 2019
 - Workshop to review consultation results April 2019
 - Text analysis of contributed "experiences" completed to highlight common themes/ideas (June 2019)
 - Now ... "just" need to pull this all together into a Draft Plan to distribute for comment ...

had intended this to be done by September – stalled.

Sorry – will get it done.

Research Funding News / Highlights

- Federally:
 - 2018 Budget provided increases to Science research ...
 impact of these is still being felt. A few things to note:
 - New Can Res. Coordinating Committee funding opportunities: New Frontiers in Research Fund (very interesting potential)
 - NSERC Partnerships programs (5) collapsed to One ("Alliance" program)
 - Changes to Tri-Agencies financial oversight (in March):
 - Principles-based accounting / eligibility decisions
 - Led to our own SMU Review of research / expense / travel policies
 ... well underway with Financial Services (
 e.g. new Expense Report)

Research Funding News / Highlights (Federally)


- Tri-Agency (still) moving forward with
 Research Data Management policies
- Focus across Tri-Agencies on Equity, Diversity, Inclusion:
 - Initiated by the Canada Research Chair program: Mandated EDI Action Plan (ours was posted end of Sept)
 - EDI is one of the 5 evaluation criteria in the new NFRF program
 - EDI was introduced into NSERC Discovery Grants this year; coming into SSHRC and CIHR soon.
 - New "Dimensions: Equity, Diversity, Inclusion Canada" program: *"foster increased research excellence, innovation and creativity within the post-secondary sector across all disciplines, through greater equity, diversity and inclusion (EDI)*" SMU has signed the charter, joining the majority of universities

Research Funding News / Highlights

- Provincially:
 - Has merged provincial research funding agencies
 NSHRC and NSRIT (and more) into one Research Nova
 Scotia agency established through legislation
 - » Will have stable/fixed budget assignment
 - » BUT: focus/priorities, supported programs all still under development (inaugural Board and new CEO in place) ... will need to wait and see how this rolls out
 - The "NS Integrated Health Research and Innovation Strategy (IHRIS)" continues to try and find its feet: hoping to improve coordination between gov/univ/NSHA, better access to health data, etc. ... Will provide updates.

Research: Recent SMU Results/Trends

- Just finished going through the first course-release-forresearch process with the Collective Agreement wording:
 - Guaranteeing release if External Research Funding is secured
 - Set up guiding criteria to define "external research funding" (\$ must come to SMU; "sufficient" amount ~\$10k; grant period at least 1yr)
 - 39 releases awarded for 2020-21 academic year
- Working through interpreting the course release for PhD supervision C.A. clause (awkward wording!)
 - Will continue to work on clarifying this interpretation for all of us.
 - 12 releases awarded for 2020-21 academic year

Research Ethics Review Requests Fall 2019







Some Notes from Research Ethics Board Chair

- processing times are 6-8 weeks
- modifications are much faster (and no need to submit a whole application)
- in research collaborations with colleagues at other Canadian institutions, it's easier/faster to undergo ethics review at SMU if the research has already received ethics clearance by another institution
- for those conducting research like activities for pedagogical purposes, we now have some guidance to help determine if that activity requires ethics review.
- Researchers can inform participants of results by publishing a brief summary on the FGSR->REB website (<u>https://smu.ca/academics/summaries-of-completed-research.html</u>). This is far better/preferred compared to asking participants to contact the researcher to find out the results.
