NEWS ABOUT OUR PROJECT

We are thrilled to announce that we recently finished the first **book** of the international GBV project with chapters deriving from diverse country-specific teams. It is expected to be out in the Fall of 2022. The book, entitled *Gender Based Violence in Migration: Interdisciplinary, Feminist and Intersectional Approaches* (Palgrave-Macmillan) and edited by Jane Freedman, Nina Sahraoui, and Evangelia Tastsoglou, features the work of the country-specific research teams. In addition, the Canadian team has an **academic paper** currently in review by a refereed publication: *The Continuum of Violence Along the Migratory Pathway: Understandings of Key Informants* (Mia Sisic, Evangelia Tastsoglou, Myrna Dawson, Lori Wilkinson, Cathy Holtmann, and Chantelle Falconer).

The GBV-MIG project will be presented in two **conferences** this summer:

1. Our **paper**, *Vulnerabilities and Strengths: Parallel Experiences of Migrant Survivors of Gender Based Violence and Public Service Providers* (Cathy Holtmann, Mia Sisic, Evangelia Tastsoglou, Lori Wilkinson, Myrna Dawson) will be presented at the Canada Excellence Research Chair (CERC) Migration Working Group at Ryerson University at the end of March 2022; and
2. Our paper on *A Journey from "Victimization" to "Re-Victimization" Among Women Migrating to Canada – Continuity of Gender-Based Violence across Borders* (Pallabi Bhattacharyya, Evangelia Tastsoglou, Lori Wilkinson, Cathy Holtmann and Myrna Dawson) will be presented at the panel *Gender and the Continuum of Violence in Migration* organized by Evangelia Tastsoglou, Pallabi Bhattacharyya, and Cathy Holtmann, in the Canadian Sociological Association's meetings at the Congress of Social Sciences and Humanities in May 2022. Four papers on the topic from various GBV-MIG country specific teams will also be discussed there. The research team is very thankful to the immigrant and refugee women, the service providers and other key informants, as well as all the team members for their respective contributions in these projects.

UKRAINE - RUSSIA WAR 2022

Russia invaded Ukraine on a massive scale, starting on February 24, 2022. The invasion alarmed the entire western world, and various economic sanctions were applied to deter Putin. Below we highlight some of the impacts.

Women and Children

90% of refugees who have fled war in Ukraine are women and children who have left their husbands, fathers, brothers, and sons behind to fight in Ukraine's resistance. UNHCR and other agencies have warned of increased risks of trafficking and exploitation.

Refugee Crisis

Over **3.1 million** refugees fleeing Ukraine are mainly going into five neighbouring countries. Over half are fleeing to Poland alone. In addition, millions are internally displaced.

CANADA'S RESPONSE TO RECENT REFUGEE CRISIS

As of March 4, Canada has only resettled 8,580 of the promised 40,000 Afghan refugees since August 2021 after the Taliban takeover of Afghanistan.

With the new influx of Ukrainian refugees that Canada prepares to receive, settlement organizations are concerned about the additional volume and further delays for Afghan refugees.
