#### **NEWS ABOUT OUR PROJECT**

Violence against Women Migrants\* and Refugees\*: Analyzing Causes and Effective Policy Response aims at a systematic and comparative analysis of the ways in which (a) various policy frameworks, social, and cultural attitudes to migration, as well as the migration process itself, combine to increase vulnerabilities to gender-based violence (GBV) and (b) government, NGOs, or regional and international policymaking institutions could help to mitigate risks, protect women, and provide better services to survivors. We have secured a book contract with Palgrave Macmillan in cooperation with the project's participating countries (France, Austria, Ireland, Turkey, Norway, and Israel). The inclusion of Canada, with its unique and pioneering policies on migrant and refugee resettlement, will provide valuable comparative data, relevant to policy makers and service providers in the larger project and on both sides of the Atlantic.


Using secondary and primary research methods, this project takes an intersectional approach and analyzes the ways in which discriminations and inequalities based on gender, race, nationality, age, ethnicity, sexual orientation, and gender identity interact to make certain women more vulnerable to GBV and less able to access support and services for survivors than others. The secondary research methods (e.g., policy analysis, mapping migrant women's associations in Canada) are completed. Qualitative interviews are the core of our primary research methods. We have completed interviews with key informants (e.g., settlement service providers) to understand, among other things, their experiences of working with recent migrant and refugee women who have experienced GBV and how services could be improved. We are currently conducting interviews across Canada with recent migrant and refugee women about their experiences, beliefs and impacts of GBV (including strengths-based outcomes), as well as interactions with service providers. \*We have adopted these terms from the common language of the multi-national project. By using them we seek to include a range of individuals with various legal statuses who arrived to Canada from other countries and have experienced GBV.

YMCA of Greater Halifax, Association of Alberta Sexual Assault Services, CISSA-ACSEI, Ontario Council of Agencies Serving Immigrants, Ending Violence Association B.C, Ending Violence Association of Canada, Elmwood Community Resource Centre and OCASI announced the launch of the National Gender-Based Violence Strategy. This project will build the capacity of settlement and anti-violence sectors to codevelop a shared base of knowledge and to better support newcomers and refugees through a coordinated, comprehensive approach. Their public-private project has been brought to life through an agreement with the Canadian government which has enacted a temporary public policy.
